Subject: Feedback re Islands 2050 Policy Statement and amendments

To the executive and trustees of the Islands Trust regarding the Islands 2050 Policy Statement and proposed amendments:

Anyone with an ounce of respect and integrity knows that:

1. transgression against ANYONE's inherent right to freedom, self determination, land ownership, and sovereignty of mind and body is not to be upheld
2. adaptations need to be made at every level due to changes in climate (based on facts, not the manufactured climate narrative).

I am deeply concerned about the Island 2050 Policy Statement and the proposed amendments, both of which centre around politicalized and UN driven agendas that have been either myopically and/or complicitly adopted by the Canadian and BC governments, such as UNDRIP and a skewed interpretation of the causes and solutions for climate changes.

Who wrote the Executive Summary to the Islands 2050 Policy Statement Amendment Project Discussion paper?

It purports to 'provide relevant historical content and current analysis to support an informed and fulsome...discussion'. Yet it is heavily biased, coloured with words that steer the reader toward blaming the Islands Trust (and consequently long-dedicated Trustees) and blaming our culture (made up of the very ones that fund the Trust) with the belaboured use of words such as 'failure to', 'horrors of', 'desecrated', 'looted', 'forced', 'neglected', 'complacent disregard', 'offensive', while using revering language to describe the plight and entitlement of the wronged First Nations since time immemorial.

This manipulative language is not appropriate in a public policy document claiming to be a foundation from which to establish a truthful perspective and the ethical integrity upon which to formulate policy for our future.

What the Policy fails to acknowledge is that perpetrations inflicted on the peoples of First Nations...

1. are abhorrent to most Canadians
2. bear similarities to hidden perpetrations that permeate ALL of our society that also need to be rectified at the source (for example, are you aware of the unexamined prevalence of sex trafficking of children right here in BC?)
3. have been funded and instigated by the same elite group that is now driving UN Agenda 21, Agenda 2030, Agenda 2050 and UNDRIP.

What about the forced removal of Japanese Canadians (who inhabited the Gulf Islands) to internment camps? Why is there no mention of them? Or is this sordid historical fact too much of a distraction from rolling out the UNDRIP agenda?

Yes, the colonization of North America involved 'violence and erasure' ...which is being cleverly repeated today upon all of us (without the use of guns) via innocuously worded legislation, unwarranted emergency measures, censorship, fraudulent health measures and bioweapons. As it stands, it will not be able to deliver true 'benefit to the residents of the Trust Area' as outlined in the objectives of the Trust. Sadly, the Islands Trust appears to have become yet another tool in the elite's hand that has successfully transferred massive amounts of wealth to themselves over the past year while the rest of us are struggling (homeless people are just the tip of the iceberg), with hyperinflation just around the corner.

We who inhabit the Islands trust area are, for the most part, capable, responsive, caring people.
