1. CALL TO ORDER AND WELCOME

4. BUSINESS ITEMS

Election of Chair, Vice-Chair and Secretary

GB-HAPC-2019-001

It was MOVED and SECONDED

that the Gabriola Island Housing Advisory Commission have a rotating Chair and the Chair is responsible for three (3) consecutive business meetings. The Gabriola Island Housing Advisory Commission to have a roster of Chairpersons and the Chair rotates in order of the roster. The next person on the roster, after the current Chair, becomes the current Vice Chair for three (3) consecutive business meetings and rotates in order of the roster.

5. REFERRAL FROM GABRIOLA ISLAND LOCAL TRUST COMMITTEE

Planner Zupanec presented a synopsis and objectives of the Gabriola Housing Options and Impacts Review Project and noted the following key points:

- Potential deliverables to the Local Trust Committee (LTC) are three weeks prior to regular LTC meetings in September 12, 2019 and February 2020;
 - September 2019 Deliverables:
 - Identify and confirm clear role and decision-making processes within Housing Advisory Planning Commission (HAPC) terms of reference;
 - Develop a collective understanding of four central themes of the project and identify information gaps and presentation options;
 - Provide recommendation to the LTC on potential changes to the Draft Engagement Strategy;
- There were four key phases:
 - Phase 1 Laying the Groundwork;
 - Phase 2 Exploring Our Options;
 - Phase 3 Exploring Our Future;
 - Phase 4 Walk the Talk;
- Priority Engagement Themes are:
 - Housing diversity and affordability;
 - Protecting freshwater aquifers;
 - People at risk; and
 - Protecting biodiversity.

Discussion ensued and the following was noted by Commission members:

- Interested in having Lisa Wilcox, Senior Intergovernmental Policy Advisor, attend meeting for a First Nations Relationship Building workshop;
- Interested in applying for a Masters of Community Planning intern from Vancouver Island University (VIU) to assist with project;
- Requested that the climate emergency and First Nations Reconciliation be front and centre in the Draft Communication Engagement Strategy document;
- Suggested more frequent meetings in order to meet deliverables to LTC; and
- Would like to start next meeting discussing addition of climate change to Priority Engagement Themes.

GB-HAPC-2019-002

that the Gabriola Island Housing Advisory Commission request Staff to apply for a Vancouver Island University graduate student intern to assist with the Housing Advisory Planning Commission Engagement Strategy.
