The Galiano LTC is expecting to receive the initial Staff Report for the Galiano Affordable Housing proposals. **LTC OCTOBER 7TH MEETING RECAP**

The LTC approved a Temporary Use Permit renewal, a Development Variance Permit, and made a motion to proceed with a commercial rezoning application. A Community Information Meeting was scheduled for DL 37 (Stevens), as well as a community open house regarding the management of STVRs. Should the LTC decide to proceed with the Stevens application, a Public Hearing is scheduled for the December 9th LTC meeting.
