Thanks Dan for your speedy response.

I am unclear how you can make the important decisions recommended by the Planner, including going to 2nd reading of the CMS proposal, without the public as well as the applicant being heard. Perhaps we can develop some mechanism (and I haven't spoken to anyone else about this, just my idea) where a few designated people can stand up and read statements from several other people who cannot be there in person because of Covid or a few people can be zoom presenters in the same way that the applicant will no doubt be allowed to speak. This would require you allowing those representing a larger number of people to have more time.

Covid has created incredible challenges in many areas and especially public participation - not just Islands Trust - and while I understand the budget issues (and am sympathetic to that reality) I do think we have a responsibility to find a creative way to allow the public to speak. You might have some other ideas about addressing the problem of public participation beyond my idea.
