1. CALL TO ORDER

Chair Rogers called the meeting to order at 12:30 p.m. He acknowledged the meeting was being held in traditional territory of the Coast Salish First Nations.

2. RISE AND REPORT – In-Camera Meeting September 8, 2020 re Adoption of Minutes and APC Appointment

Chair Rogers reported that the in-camera minutes of the Local Trust Committee (LTC) meeting of September 8, 2020 were adopted and the LTC appointed Robin Paterson to the Galiano Advisory Planning Commission (APC).

3. APPROVAL OF AGENDA

By general consent the agenda was approved as presented.

4. TRUSTEE REPORT

Trustee Wolverton reported on the following:

- Participation at the latest Trust Council meeting, meetings with residents, site visits and research conducted since the last LTC meeting; and
- A new virus on Galiano and other nearby islands that is killing deer.

Trustee Rockafella reported on the following:

• A letter from the LTC to the Galiano Conservancy Association (GCA) in support of the Ecological Footprint Project.

5. CHAIR'S REPORT

Chair Rogers reported on the following:

- Trust Council was held electronically with an increased number of delegations than usual – including presentations related to climate change, bylaw enforcement and expansion of the docks in Tsawwassen;
- Trust Council has been engaged in discussions regarding meeting logistics in response to COVID-19 in 2021:
- The meeting held by the Union of BC Municipalities included thought provoking presentations on racism; and
- The Islands Trust Climate Change Speaker Series has begun.

6. TOWN HALL AND QUESTIONS

The following comments were made regarding GL-RZ-2014.1 (Crystal Mountain):

- Neighbours of Crystal Mountain Society (CMS) expressed mixed views for the application;
- Opponents noted that the north end of Galiano already has two commercial zones and the proposed development would set precedent;
- The application would allow for the largest accommodation on the island;
- The current proposal differs from that of the 2017 agreement and is more ambitious than the proposal sent to neighbours in 2020;
- The application does not provide enough information for evidence-based decision making;
- Application GL-RZ-2014.1 requires:
 - o comprehensive mapping to accurately reflect biological resources;
 - o greater detail about tent pads, land use limits (density) and emergency access;
 - o water and waste management plans; and
 - o a plan for the removal of outhouses.
- The application poses environmental risks such as increased fire hazards (from cooking facilities), negative impact on the wetland, forest fragmentation, and reduced water availability to neighbouring residents on Porlier Pass Road;
- Mitigating climate change should be a priority and there is a need to exercise caution when developing land; and
- CMS has operated without bylaw approval.

13.1 GL-RZ-2014.1 (Crystal Mountain) – Staff Report

Planner Smith reviewed the Staff Report related to GL-RZ-2014.1 (Crystal Mountain). Discussion was held and the following comments were made:

- Subdivision approval will require that road access meets a certain standard on both hooked lots, access challenges exist with upper hooked portion;
- Huts may be limited to single-person occupancy via bylaw or covenant;
- Proposed environmental assessment update could include a review of proposed alternative driveway routing;
- Parking needs more detailed consideration;
- The hydrogeologist's report deems the water quantity of the wells sufficient to support land use;
- Applicants would need a commercial water license;
- Galiano has used site specific zoning in the past (ie the film school and eating disorder clinic);
- Greater definition of tent platforms, including their square footage, should be included in the bylaw; and
- Questions raised as to what constitutes food preparation facilities.
