Regarding proposed Bylaws 194 & 195 related to rezoning of St. John Point Park:

Living close to the park, we frequently transit the parking area. Over the course of the last year we have not observed an overcrowding of the parking area.

Due to this observation, we would like to recommend that the parking demand be monitored as to the need for additional parking before incurring the expense and loss of park area with the addition of parking.

With regards to the impact of traffic on local residents, the vast majority of park visitors are very respectful of the environment and the surrounding properties. The number of incidents involving bad actors seem to involve dogs which are either uncontrolled or encouraged to bark by their owners. It would seem reasonable that signage could request control of dogs by their owners.
