# Riparian Regulations and Sensitive Ecosystems - important

As there has been a turnover of new property owners, many of whom are interested in possibly building, I have attached the plain language copy of the riparian area brochure that was sent out last year. It is a good reminder to everyone that all private land on the island is now covered by a Development Permit Area that will require anyone who is building/developing/clearing (with a few exceptions - see brochure) to go through the permit application if the land disturbance is within 30m of a water or wetland feature.

What may not be intuitive is that this includes:

- features that contain water or are wet only part of the year
- road-side ditches
- dug ponds

It doesn't mean you cannot build within this setback area; it just means an environmental report is required to determine mitigation measures. The trigger for this report is as soon as you consider altering land within 30 metres of any water feature including a simple driveway across a ditch.

#### WHY??????

Water is a defining aspect of biodiversity as well as human habitation on an island. Any disturbance of land - including clearing, digging, and building, affects the ability of the land to retain and recharge the water table.

Gambier Island is completely dependant on rainfall for water. It does not have access to snow-pack storage nor is the island connected to an accessible deep rock natural reservoir. Using the provincially required Riparian Area Protection Regulations and including all wetland/water-course features in a development permit area is the least onerous mechanism the Islands Trust has to protect this precious resource that we all rely on.

Gambier Island is one of the very few islands in the Salish Sea that is not facing ongoing serious water shortages. The Sensitive Ecosystem Development Permit Area is how we all take responsibility for maintaining a healthy island.

**Budget:** Every spring the Trust Council passes an annual budget. I want to thank everyone on Gambier who made the effort to participate in the survey. The responses from our island ran the gamut from "reduce taxes and programs" to "increase taxes and programs" but the majority of respondents were in favour of keeping taxes and programs the same. As I voted for a budget that included a 3.5% tax increase\* to landowners, I would like to state why:

- I have sat on the Finance Committee for more than a year and participated in line by line examination of ways to cut the budget. It was a robust and difficult process.
- The Trust is seeing a variety of important initiatives coming to fruition. I don't want to see their value jeopardized by cutting them now.
- The majority of the Islands Trust budget is staff salaries set by the BCGEU agreement with the province. Their step increases are not negotiable and planning staff, as well as staff of the level of expertise at the Trust, are very sought after across Canada and cannot easily be replaced.

## OF INTEREST TO THE SOUTHWEST PENINSULA

Roads Committee – As Joyce Clegg is no longer on the island, the local roads committee has gone dormant. I would like to re-start the committee as a liaison between the community on the South West Peninsula and Capilano Road Services to ensure ongoing maintenance issues are addressed; including scheduled dust control and verge trim in the summer and salting/snow clearing in the winter. The Committee generally meets twice a year (spring/fall) with the Capilano staff. It is a straightforward

operations style meeting and usually doesn't last more than 1½ hours. If you are interested in participating please let me know and I will organize something with Tyler Lambert – Capilano Operations Manager and Scot – on-island maintenance, for sometime in May.
