Islands Trust Policy Statement – virtual event For Gambier Islanders March 28th

A flyer was recently delivered to everyone's mailbox about the further engagement opportunities for *Islands 2050*. This is a Trust-wide process to modernize the vision and goals of the mandated high-level guide to island planning across the Salish Sea that has been ongoing since 2019. It is like a Regional Growth Strategy that is required for other communities in BC. **This is not the Gambier Island Official Community Plan**. New topics that are being addressed include approaches to:

- reconciliation,
- climate change,
- forest stewardship,
- affordable housing,
- desalination,
- docks and seawalls.

If the grant is successful SCRD staff will coordinate with the island communities and develop a detailed project plan.
