Information session added to Trust Council town hall meeting

Lak waŋan, METULIYE/Victoria, B.C. – A short information session will be offered prior to the Islands Trust Council's July 7, 2021 7:00 p.m. town hall session at 6:30 p.m. The intent is to provide an overview of the current Policy Statement amendment process and share information about the next public review and engagement process, which will go on for a number of months and involve the public, First Nations, agencies, and organizations.

"It's inspiring to see so many people talking about the Policy Statement, and we are thrilled with the level of interest," shared Peter Luckham, Islands Trust Council Chair. "Still, we're concerned about misinformation, and we are deeply discouraged by the antagonistic and blaming dialogue we have witnessed. In the 26 years since the Policy Statement was last updated, the world has changed, and our priorities have shifted. As we consider updating and strengthening the Islands Trust's policies to address reconciliation, climate change, and affordable housing it is invaluable that so many community members have shared their values, concerns and ideas over the last 18 months, and that so many are keen to join the process."

Despite rumours circulating, the draft new Policy Statement doesn't centralize governance, cause the Islands Trust to work outside its jurisdiction, result in less support for healthy and inclusive communities, or cause anyone to take out existing infrastructure such as docks and seawalls. Reading the draft new Policy Statement cover-to-cover is essential to understanding how everything is interconnected.

At the July 8 Trust Council meeting, first reading of the draft new Policy Statement will be considered and a multi-month public engagement process will begin.
