Islands 2050 is a trust-wide public engagement process designed to help the Trust revise the Islands Trust guiding document, the Policy Statement. The Policy Statement guides the preserve and protect mandate of this special-purpose local government, and guides policy decisions about island landscapes and the waters surrounding them. It includes recommendations to other levels of government and notably it informs how local official community plans (OCPs) and land use bylaws are developed.
