What should be our top priorities in determining how much of various kinds of development to allow?  For example, clearcutting one's property should be seen as development, and restrictions on this might be considered an easy place to start, It becomes more complex when we look at rising levels of tourism, with its economic benefits (for some), but also its effects on inhabitants and infrastructure. Some places with a longer history than ours (e.g. Venice). are recognizing and beginning to deal with this problem.  My lifetime observations suggest that it's usually best to observe the precautionary principle. Once a policy is instituted, plans are in place, and development is begun, it's most often impossible to stop it. There are myriad examples, but one is Canada's hugely expensive efforts to sell tar sands oil to the world.  There will always be people whose main concern is to make money out of any "resource" (group, location, commodity - almost anything can count as a resource), but such people must be resisted. We should not allow ourselves to be intimidated by wealth and loud voices.  If you have read this far, thank you.  Gregory Nicholls
