RECOMMENDATIONS

1. That the Gabriola Island Local Trust Committee direct staff to prepare draft bylaws to amend Gabriola Island Land Use Bylaw No. 177 to establish an Ecological Protection Zone in accordance with the "Ecological Protection Zone" project charter v 1.0 dated January 24, 2019.

REPORT SUMMARY

The purpose of this report is to provide background information and bring forward draft land use bylaw provisions and policy language to be considered by the Gabriola Island Trust Committee (LTC) in order to establish an ecological protection (EP) zone in Gabriola Island Land Use Bylaw No. 177, 1999 (LUB). Per the staff recommendation, the LTC may request staff to prepare draft bylaws for referral, readings and public hearing in order to facilitate rezoning of Coats Marsh Regional Park and Burren's Acres Nature Reserve, as described in the "Ecological Protection Zone" Project Charter v 1.0 dated January 24, 2019.

BACKGROUND

The LTC passed the following resolution at their meeting on January 24, 2019:

GB-2019-119 It was MOVED and SECONDED that the Gabriola Island Local Trust Committee approve the "Ecological Protection Zone" Project Charter v 1.0 dated January 24, 2019. <u>CARRIED</u>

In response to LTC direction, staff has drafted a zone framework with provisions and language for consideration by the LTC in advance of necessary referrals to affected local First Nations and agencies.

Coats Marsh Regional Park was donated to the Regional District of Nanaimo (RDN) and Nature Trust of BC (TNT) in 2008 through the federal Ecological Gifts Program and is managed under the RDN management plan for the park that extends to the year 2021; an update is pending.

Staff has contacted the RDN and TNT to discuss options and gather input as to their interests on the parcel, particularly concerning permitted uses and structures in order to align with the current management plan that is in place. It has not been possible to coordinate a meeting between all parties or receive substantial input up to the time of writing this report. However, staff feel that in the interest of expediting the top priority project, the

Staff will continue to communicate with the RDN and TNT to ensure any concerns are addressed. To this end, a tentative meeting date has been set for the week of August 19th.

For further background regarding the inception of the project and information on the proposed rezoning of the subject properties, please refer to the <u>Staff Report dated January 24, 2019</u>.

ANALYSIS

Policy/Regulatory

Islands Trust Policy Statement

A preliminary review of the Islands Trust Policy Statement (ITPS) is provided for consideration in **Attachment 1**. Staff would undertake a full review of the ITPS before second reading of the draft bylaws.

Official Community Plan

Development of land use regulations for the purpose of ecological protection is consistent with the objectives and policies of the Gabriola Official Community Plan (OCP). Polices relevant to both the development of conservation/protection type zoning and to the subsequent re-zoning of the two properties is presented in **Attachment 2.**

Land Use Bylaw

An LUB amendment would create and add the EP zone to the bylaw, including text and map schedules. Since it is the opinion of staff that no OCP amendment is needed at this time, the draft bylaws could be referred to the Executive Committee prior to the statutory public hearing and before third reading without the need for approval by the Minister, as is the requirement for OCP amendments.

In the current draft state, the EP zone would necessitate two additions to the Definitions section of the LUB to properly clarify uses not specifically contemplated by the current document:

NATURE PARK means the use of land, buildings or structures primarily for the conservation and enjoyment of natural areas. Uses can include boardwalks, trails, environmentally sensitive area protection, nature sanctuaries and the like.

ECOLOGICAL RESTORATION is the process of assisting the recovery of an ecosystem that has been degraded, damaged, or destroyed.

Issues and Opportunities

Islands Trust Conservancy

Development of an EP zone presents an opportunity to directly further the conservation goals and objectives of the Islands Trust Conservancy Regional Conservation Plan (see <u>pages 35-37 of the Regional Conservation Plan</u>).

OCP Review

An opportunity exists to amend OCP language around the Parks (P) Land Use Designation to more accurately reflect the objectives of the proposed EP zone, should those bylaws be adopted. Staff feel that this could be accomplished as part of a future OCP review and is less immediately critical since the OCP adequately supports ecological

protection in its current form, as demonstrated by staff analysis of relevant OCP Objectives and Policies in Attachment 4 to the <u>Staff Report dated January 24, 2019</u>.

Inclusion of Potlatch Donor Lands (707 Parkland Additions)

The land recently added to the 707 Community Park via the 2016 Potlatch rezoning application and associated density transfers, could be considered candidates for inclusion in the new Ecological Protection Zone. Given the proximity to Coats Marsh, an opportunity presents itself again at this time for increased protection while the LTC considers rezoning Coats Marsh itself.

Discussion around the difficulty in acquiring large portions of land on Gabriola for the purpose of preservation and protection, where human recreational activity would be a secondary focus to conservation, arose as part of the above-mentioned application. The donor lands adjacent to the 707 are currently zoned Forestry Wilderness Recreation 1 (FWR1) by reason of the fact that they were added to the RDN Community Park and acquired the same zoning. Coats Marsh currently retains its Resource (R) zoning despite its status under the Ecological Gifts Program. Part of the intent of the Ecological Protection Zone project at its inception was to include the subject rezoning properties under the OCP Parks designation at an appropriate future opportunity.

By including the 707 parkland additions as rezoning candidates in the Ecological Protection Zone project, further protection could be provided for the sensitive Coats Marsh ecosystem - particularly the wetland in the south-east area of the park, since it extends across the common interior lot line and into the smaller addition area.

The current RDN management plan for the 707 Park provides for the creation of park amenities that enhance recreational function with no negative impact on its ecological and cultural values. Notwithstanding this historic and current low-impact and passive recreation focus, further impacts to the marsh from the creation and/or extension of the trail network or other amenity development could perhaps be mitigated by the inclusion of the parkland additions that would see a conservation rather than a recreational focus applied through zoning.

Consultation

The LTC should consider if it wishes to undertake consultation with First Nations, School District (SD) 68, agencies or adjacent local governments beyond what is required by statute and protocol agreements that are in place, and direct staff accordingly.

Statutory Requirements

Since it is the opinion of staff that the creation of an EP zone and the proposed rezonings would not require OCP amendment at this time, a public hearing (or public hearing waiver) prior to third reading and adoption and approval by the Executive Committee of any proposed bylaws would fulfil statutory requirements. Notwithstanding, see the below section of this report titled "First Nations" regarding Trust Council First Nations Engagement Principles.

Protocols

The following protocol agreements exist and are relevant to bylaw referrals in relation to the project:

- Protocol Agreement and Letter of Understanding (LOU) between the Islands Trust and the Regional District of Nanaimo (RDN) regarding each local government's jurisdictions and responsibilities, and coordination between the Islands Trust and RDN staff.
- Protocol Agreement between the Snuneymuxw First Nation and the Islands Trust Council (on behalf of the Gabriola Island LTC) that identifies matters in which the LTC will consult with Snuneymuxw First Nation.

First Nations

Both subject properties are within the asserted territory of the Snuneymuxw First Nation as well as seven other First Nations and one Treaty Group, according to the BC Provincial Consultative Areas Database¹:

- Cowichan Tribes
- Halalt First Nation
- Lake Cowichan First Nation
- Lyackson First Nation
- Penelakut Tribe
- Semiahmoo First Nation
- Snuneymuxw First Nation
- Stz'uminus First Nation (Chemainus)
- Hul'qumi'num Treaty Group

As mentioned, review of applicable OCP policies suggests that the creation of an ecological protection zone and the subsequent rezoning of the subject properties would not require a corresponding OCP amendment since the intent of each is deemed to be consistent with the OCP, the Islands Trust Policy Statement and the Object of the Trust. Regardless, in accordance with the Trust Council First Nations Engagement Principles, staff recommend that the LTC provide local First Nations with early and ongoing opportunity to comment on any draft bylaws, particularly in light of Trust Council's recent Reconciliation Declaration adopted on March 14, 2019.

Rationale for Recommendation

Development of an Ecological Protection Zone and the proposed rezoning of Coats Marsh Regional Park and Burren's Acres Nature Reserve is substantially in compliance with the Islands Trust Policy Statement, aligned with the provincial Object of the Trust, and directly furthers the conservation goals and objectives of the Islands Trust Conservancy Regional Conservation Plan.

ALTERNATIVES

1. Direct Staff to Draft Alternate Language

The LTC may wish to consider changes to the draft zone language and regulations themselves. Recommended wording for the resolution is as follows:

That the Gabriola Island Local Trust Committee request staff to amend the draft ecological protection as follows: (Specific details to be provided by the LTC).

2. Proceed no further

The LTC may choose not to proceed with this project at this time. Recommended wording for the resolution is as follows:

That the Gabriola Island Local Trust Committee request staff to remove "Development of an Ecological Protection Zone" from the Top Priorities List and place it on the LTC Projects List.

NEXT STEPS

Should the LTC so direct, staff will prepare draft bylaws with any requested changes by the LTC in advance of the necessary referrals before adoption and in preparation for the rezoning of the subject parcels.
