APRIL LTC MEETING NOTES

- A delegation from Galiano Affordable Living Initiative (GALI) updated the LTC on the planned development of the Galiano Green property. Trustee Rockafella recused herself from this application.
- -A setback variance was approved for Norgang/Allen.
- -Crystal Mountain Society submitted an updated application. A Community Information Meeting was scheduled date TBA.
- -A request to support inclusion of land (Falk) in the Agricultural Land Reserve was approved.
- -The Projects List was amended to drop the Forest 1 Conservation Covenant Rezoning Option. The LTC plans to follow up on the status of DL87 (F1 to Nature Protection) which has been in abeyance since 2008.

SOUTHERN GULF ISLANDS FORUM

The inaugural meeting of this group which includes Trustees, MP, MLAs, Regional Directors and First Nations representatives, took place in March. The purpose of this group is to speak with a collective voice on the issues on which we agree, and hopefully have a stronger impact with all levels of government.
