Trustee Stamford Report - March 1, 2019

Gambier/Keats Island Local Trust Committee - The next regular business meeting will be held on March 21st at the John Braithwaite Centre beginning at 10:30am. The agenda package will be available on the website a week prior.

Activities:

Gambier/Keats Local Trust Committee Meeting January 31st - Reviewed top priorities for the upcoming year. The Local Trust Committee will continue with finalizing riparian area and wetland ecosystem protection on Gambier, foreshore protection review on Keats and a comprehensive review of the Gambier Island Official Community Plan. Appropriate staffing continues to be a challenge for the TLC's projects as we are still very active with rezoning and subdivision applications with both Keats Camp and Sea Ranch as well as variance applications.

Forestry Webinar – I attended a webinar hosted by staff from the Ministry of Forestry, Lands, Natural Resources and Rural Development (FLNRORD). Ocean Watch Task Force - Chaired two OWTF meetings this year to advance local government action items in the Coast Ocean Research Institutes summary of actions for Howe Sound including a strategic planning session in January.

Islands Trust Conservancy - As Chair this year of the IT Conservancy, I have begun working with the staff and board to advance new funding options in the support the acquisition and management of reserved lands on the Islands in co-operation with First Nations, other conservancies and private partners. I also participated in the Conservancy webinar to discuss the management plans for the current land reserves on Gambier along with several members of the Gambier Island Conservancy. Second Trail Sign Gone – the pottery sign at the entrance to the Mountain Road Trail in

West Bay has disappeared in a similar manner to the sign off Heron Trail. These signs were designed and erected by Morgan Campbell as a volunteer project as a beautifying gesture for the area. It is appalling that someone on the island is stealing these signs. Any information that would help in their return would be appreciated.

Roads – For new community members Capilano Highway services is contracted by the province to provide snow clearing to the primary roads (Gambier Harbour to West Bay and Grove road as well as just past the Erricos on Andy's Bay Road to New Brighton). A big thank you to Kevin for clearing the roads during these last few weeks of icy weather on behalf of Capilano Road Services.

Wolves and Cougars – indigenous predators continue to be spotted around the Island – on beaches and peering through windows. Please keep your two and four-legged family members close at all times.

New Brighton Dock – To date, there has been is no new information about when expected maintenance repairs on the pier, pylons and floats will happen. I email the facilities manager roughly once a week to inquire, but have not had a response yet. Several members of the Skwxwú7mesh Uxwumixw Council have told me they are currently in discussions about the dock and this could be part of the reason for the delay with the repairs that were expected last fall.

There continues to be no plans to change the ownership/management of the New Brighton Dock. Khelsilem, the spokesperson for the Council, has contacted me to confirm this. There is also a response from MP Goldsmith-Jones in regard to the Federal Government's further role in the facility to be found here:
