Islands Trust Federation

The Islands Trust is in the process of re-designing and modernizing its website to make it more user friendly for mobile use. The Council also continues to investigate ways of streaming meetings both at the local and the federation level. The Islands Trust is uniquely challenged by mobile and remote meeting locations that do not provide consistent internet service for the level of recording that is required for local government. This continues to be a priority for Trustees in their desire for a more public engagement at all levels as well as lessening the carbon footprint/cost of travelling.

Trustee Activity

The Local Trust Committee Met with Metro Vancouver Area A Director Jen McCutcheon, her staff as well staff from the Islands Trust. The Local Trust Area includes planning authority for Passage and Bowyer Islands that are in the Metro regional district, so we meet every other year or so to address islanders' issues. Concerns on these islands include continued parking/moorage at West Vancouver Marina, emergency services especially fire response, and the finalization of riparian area regulations.

The Local Trust Committee met with our new MP Patrick Weiler to introduce him to the Gambier/Keats area and the special purpose local government that is the Islands Trust. We discussed the importance of enforcement of federal regulations especially around fishing and the protection of glass sponge reefs around the islands. Derelict vessel and marine debris continue to be a challenging multi-jurisdictional issue. We highlighted the importance of regional initiatives such as the Biosphere and Islands Trust Conservancy priorities in the Howe Sound Atl'ka7tsem area. MP Weiler expressed interested in the Trust's First Nations Reconciliation Action Plan. I also outlined the ongoing uncertainty around the New Brighton Dock and look for his support in finding a long-term workable solution for the community.
