My extended family and I have owned a summer home in Plumper Cove since 1938. During that time, i believe that we - and all of our neighbours - have been good stewards in protecting the ecology of the Cove without having the threat of bylaw infractions to motivate and guide our behavior. I am vigorously opposed to the proposed new restrictions regarding "structures" that will seriously restrain the owners of virtually every cabin in the Cove to do the kind of reasonable maintenance work to protect our summer homes without the need for potentially expensive and time consuming regulatory approvals. My unhappiness is made more acute upon learning that the feedback and invovlement of our Plumper Cove representatives in the "planning process" appears to be largerly ignored. It appears that an agenda is being advanced that cares little what the actual residents of Keats Island support. While I too am unable to participate in the scheduled meeting I would be happy to have this email shared with those who are able to attend the meeting.

- > Hi Dan. We are enjoying our piece of paradise on the north side as we speak.
- > Our access to zoom and stuff is very limited when we are on Keats so I am not likely to join the call.
- > But just so you know, I (and likely other Plumper Covers) will be responding more completely during the public workshop process.
- > As you know most places in plumper cove have been occupied and "managed" for many decades. There are

numerous "structures" within the current 7.5m DPA that are decades old and may not be "lawful". I hope that as such structures as walls and decks need a little attention to stop them falling into disrepair, that these historic features will be given some grace to allow them to retain their value to the cottage owners. A proposal to extend the DPA will capture more historic structures (perhaps including some of the original cabins) that will add to the challenges of maintaining our summer homes at a reasonable cost and amount of effort.

- > As a possible highlight to this matter, the proposed constraints on tree pruning will likely be quite problematic. Trail and view maintenance require regular branch and top removal, but never to the detriment of the tree.
- > I am glad to see that dock lengths have been removed. As noted in a previous email, no docks in plumper would be functional boat dock with the 30 m limit proposed earlier.
- > Perhaps I am being petty, but I am a bit disappointed there is no reference to the working group composed of Keats Islanders that met several times to provide feedback and info to island trust. A minor tip of the hat will go a long way to getting volunteers to participate in future IT initiatives.
- > In closing, I had hoped/anticipated that you would have provided some profile to the shoreline project in a periodic IT director update. While not as dramatic as fire safety or coyotes, I think this matter is of keen interest to (and affects many) Keats islanders.
