Hi Alex,

Thanks for your response.

My main concern is that we were never directly notified or consulted with about this recommendation. The only way we heard about being named was through the rumor mill on Hornby.

Furthermore, it does not "seem" we were named. We were directly named along with Lorena. If the APC had concerns with glamping, I would have thought they named "glamping"... which they did not. There are many other ALR zoned properties which were not listed specifically and by name that offer glamping.

I am more than happy to have community consultation. However, I wish that we are given the opportunity to educate the community, especially those involved in special anti tourism interest groups.

Although this is still in its infancy, I would like to address the apparent concerns that the APC has with Lorena and Fossil Beach directly. Is there an avenue to do this? What would be most appropriate? Write a letter addressed to Island's Trust? the APC? Speak at a meeting? etc.

Can you also clarify what decision you will be making?

Hi Jeff,

We are only at the infancy stage. These are only recommendations and we have a whole iterative process to go through. At our next LTC meeting, staff will provide a timeline (project charter) for how the OCP LUB review (STVRs, First Nations, Housing and Riparian mapping only) will play out, which could be over a year.

In the meantime, nothing will happen until we go to the community and hear concerns, feedback etc. I know it probably seems like you were targeted, only that glamping is not in our official community plan. Does it need to be? Who knows? We shall see how the community feels. I will let you know the timeline once we have the staff report.

As I said, these are only recommendations. I am will be waiting to hear from the community and farms like you to share your views and concerns before I make any decision. A

It is my opinion that we have many bylaws that govern the use of our property and see that this recommendation isn't valid.

We currently fall under and adhere to provincial bylaws of:

Agriculture Land Reserve and Commission
Liquor and Cannabis Regulation Branch
Drinking Water Protection Act

We also fall under and adhere to regional bylaws of:
Island Health (which includes water and septic)
Comox valley Regional District

As well as adhering to local bylaws of the Islands Trust.

We also have built our farm and our operation being guided by the current OCP, where it's clear that local farming and food sustainability is a prominent feature.
