Only a few items of note to report on this month.

1. Vancouver Island Regional Library: VIRL will be slowly restoring some in-branch services. See <https://virl.bc.ca/library-services-in-the-new-normal> for information on what will be available and when. The VIRL Board continues to meet remotely.

2. Local response to Covid-19: It seems likely that resumption of activities in the current context will be a slow, steady process. The Province is taking steps in phases with time to monitor and adapt to the unfolding situation. If there are major changes in services on Lasqueti, I will do my best to put out notices. If you become aware of an important change, please let me know.
