These reports document the following:

- 1. The well level measurements indicate that the available water is not subject to significant variation during the time tested, and further supports the plan to develop 10 units at 375 Village Bay Road, proposed lot 3.
- 2. The water management plan addresses questions arising about the availability and suitability of well water and gives direction on management of potable water. Additional topics discussed include the management of rain water, the need for water for fire storage, and storm water management during construction and operation.
- 3. The revised site plan shows a shorter access onto the site from Village Bay Road, minimizing headlights crossing the western boundary and providing smoother on-site traffic. The rerouted driveway includes a hammer head turnaround and eliminates the loop around the heritage tree into the western setback.

With this additional engineering work, Mayne Island Housing Society has confidence that we have addressed the concerns identified by the Advisory Planning Committee.
