### 1.3 Approval of Draft Minutes for July 15, 2021

### It was MOVED and SECONDED,

That the minutes of the July 15 2021 Ganges Village Area Task Force meeting were adopted as amended.

#### 2. NEW MEETING SCHEDULE AND LOCATION

Planning Team Assistant Pingle reported that the Task Force has requested two meetings per month. The first meeting of the month will have a minute taker in attendance and the second meeting of the month will have staff and a minute taker in attendance.

There was a suggestion to schedule the Ganges Village Area Task Force meetings and the Housing Action Program Task Force meetings at different times to allow members to attend both meetings.

### It was MOVED and SECONDED,

That the Ganges Village Area Planning Task Force request staff to schedule a second meeting on the first Thursday of each month and that a first order of business would be to review how the meeting schedule would align with the Housing Action Program Task Force meetings and whether members would want to take the opportunity for a walk around.

### 3. UNFINISHED BUSINESS

### 3.1 Study Area Boundary

### 3.1.1 Study Boundary Presentation – Member Dunnison

Member Dunnison presented a PowerPoint presentation entitled "Ganges Village a Brief Historic Perspective" and circulated a PDF of the presentation to members.

In discussion the following comments and questions were noted:

- There was a question regarding the two-kilometer circle. The First Nations portage route between Ganges Harbour and Booth Canal is 2 kilometers and this is also the area of a significant Japanese settlement.
- There was a suggestion to replace the draft Ganges Village Area Plan Study Area Boundaries map with fuzzy circles as provided in the PowerPoint presentation.
- There was a suggestion that the task force consider how to anchor the four corners of the containment area of the Ganges Village Area.
- There was a suggestion that the draft Ganges Village Area Plan Study Area Boundaries map is a starting point for discussion.
- It is important to consider Ganges as a whole to relate a cohesive framework where things make sense.
- There was a question regarding why fuzzy circles would be better than the lines in the proposed Ganges Village Area containment boundary. There was a comment that there are too many fundamental details that need to be considered such as why Embe Bakery and Upper Ganges are not included in the proposed map.
- There was a comment that the boundaries on the proposed Ganges Village
  Area containment boundary are contentious overall and there is a need to
  learn more about Ganges including services such as Ganges sewer.
- There was a comment that there has to be a map for a basis of discussion and a suggestion to amend the proposed Village Containment Boundary as follows: extend the boundary to the southeast to align with the study area boundary to include lands on both sides of Ganges Hill to the blue line; extend the boundary out into the harbour to include all of the marina's; extend the boundary to the northeast to include Moby's and Harbour House; extend the boundary to the north to include the Housing and Senior's Housing lands; extend the boundary to the west to include the lands east of the southern extension of Atkins Road.
- There was a suggestion to consider a broad vision for the Ganges Village.
- There was a comment that it is important to go back in history to a time when Ganges Village did function well. There was a time when Central was considered the centre of Salt Spring Island. There was also a time when Walker's Hook was going to be the core village of Salt Spring Island. There are too many variables and support was expressed for a more open vision as the basis for discussion going forward.

### It was MOVED and SECONDED,

To replace the draft Ganges Village Area Plan Study Area Boundaries map as presented by staff with circles of areas of interest as proposed in the PowerPoint presentation.

### It was MOVED and SECONDED,

The Ganges Village Area Planning Task Force will consider anchoring the innermost fuzzy circle and some of the corners of the fuzzy circles at the September 2, 2021 meeting.

A member reported he is in the process of meeting with several groups related to harbour marinas and will report back to the task force.

There was a question regarding the stakeholder list. Planner Garbo will circulate a stakeholder list to task force members. It was noted the stakeholder list would be added to the next meeting agenda.

Member Moffatt arrived at the meeting at 11:30 a.m.

There was a question regarding the public engagement consultant. Planner Garbo reported the Salt Spring Island Local Trust Committee (LTC) will meet with the consultant at the next LTC meeting and an introductory meeting will be scheduled in September 2021.

A member asked if a transportation representative would meet with the task force. Chair Jenkinson reported the Salt Spring Island Transportation Commission has offered to guide task force members on a walking tour regarding transportation issues. The Salt Spring Island Transportation Commission (SSITC) has also asked if a task force member would like to participate in SSITC meetings as a liaison.

There was a comment that it would be timely to consider a bypass route prior to the Ganges Hill improvement project.

**By general consent,** the Ganges Village Area Planning Task Force request staff to schedule a Ganges Village site visit on Thursday, August 26, 2021 and that the group will meet at Embe Bakery.

Chair Jenkinson reported the following meeting would be scheduled on Thursday, September 2, 2021. Agenda items will include the Ganges Village Area Study Boundaries (specifically how to anchor the four corners of the containment area of the Ganges Village Area), the Proposed Area Plan Elements list and a stakeholder's list.

"A village is a small settlement usually found in a rural setting...


In most parts of the world, villages are settlements of people clustered around a central point. A central point is most often a church, marketplace, or public space...


## Ganges Established

The opening of Mahon Memorial Hall in 1902 as an agricultural hall to serve all of the Gulf Islands and the establishment of mercantile stores in 1904 made Ganges Harbour the centre for Gulf Island commerce and society.

Land at the head of the harbour was acquired as a ranch (homestead) by the English Tolson brothers. Leonard sold the land to Arthur Ward who, in 1912, subdivided the land into what is now Ganges Village.





In terms of #2, the tabulated summary, this information was extracted from the work that Staff did to provide us with a status report on the Final Policy Proposals (May 2007) for the 2008 OCP.

I reformatted the proposed Policies and Targets into tabular form for (slightly) easier reference and to allow some simple statistical assessments. At the very bottom of the file there is a table that indicates there were a total of 235 items (Targets and Policies), of which 11% were indicated as "Implemented".

Thus, the information in the table is not new, but has just been restructured for easier review.







- Discussion and deliberations on the project **must occur at a properly convened meeting, open to the public.** The details of the site visit must be disclosed to the rest of the Task Force.









#### SALT SPRING ISLAND OFFICIAL COMMUNITY PLAN

And Recommended Walkways Leading from the Ganges Village Core






Thanks David, this tabular format is very helpful.

It inspired me to consider why the implementation numbers might be as low as they are.

I looked at the "Responsibility" column to determine how many of the proposed targets and policies are achievable within the legislated authority (land use planning authority) of the Islands Trust. My results are;

- 20% (48) of the proposed targets and policies are clearly within the legislated authority of Island Trust;
- 62% (144) of the proposed targets and policies are clearly not within the legislated authority of Islands Trust; and
- 18% (40) of the proposed targets and policies are partly with the legislated authority of Islands Trust but also with the jurisdiction of other agencies.

These numbers might help explain the relatively low implementation numbers. Of the targets and policies that are reported as implemented (26 or 27);

- 60% (16) of the implemented targets and policies are clearly within the legislated authority of Island Trust;
- 11% (3) of the implemented targets and policies are clearly not within the legislated authority of Islands Trust; and
- 29% (8) of the implemented targets and policies are partly with the legislated authority of Islands Trust but also with the jurisdiction of other agencies.

(I appreciated that we don't know if targets and policies that have been implemented by others can be attributed to the 2008 document)

From this information and to the extent that we might choose to review the proposed policies, we might consider re-ordering them. First, those proposed policies that are clearly within the legislated authority of Island Trust; second, the proposed policies that are partly within the legislated authority of Islands Trust but also with the jurisdiction of other agencies and third, the proposed policies that are clearly not within the legislated authority of Islands Trust. This order might help us prioritize our discussions.

We also added RCMP as a category and I thought of Schools, however, I do note we have Education listed above. Fire Hall was added.

We were each looking into deciding which categories we would like to individually study on a deeper level or bring in deeper expertise on the matter.

From my point of view, we noted that there are already work projects and studies going on here on Salt Spring that we can draw from.

For example, the Islands Trust has projects currently going on to study Coastal Douglas Fir ecosystems as well as a watershed study project.

I brought it up that the CRD PARK and REC has been in communication with RCMP and has invited the RCMP rep to their meetings in the past. This is to do with their interest in Ganges safety.

In terms of future directions, I believe that we refreshed our minds on how to approach this long list.

In terms of time being short, we are able to directly access many studies that are already being undertaken by the Islands Trust, so none of us has to go back to the beginning to learn of what is what around Ganges.

My understanding of what we are doing in the Ganges Task Force is to find a way to densify Ganges without compromising the watersheds or the coastal douglas fir areas and to have a walking village that can serve the needs of a mixed demographic. I have been holding this concept in my mind as we work. Please feel free to write your other understandings of our purpose as you see it.

I did find our meeting beneficial and I did take home my own to do list from what we discussed.

- Robin mentioned that she is interested in studying the sewer infrastructure for Ganges. I do have sewer maps to share with Robin that show how where the sewer is currently, and how it has been added to and developed every year since it was first built
- I have already been attending the SSI Transportation Commission meetings again, so I
  will endeavor to continue with those meetings as well as to attend more meetings
  including CRD PARKS.
- I am hoping to communicate with the schools, as I believe Robin will too, as there is a large youth population right in Ganges and most of the public lands are owned by School District #64. I may possibly resume attending the school board meetings as I once did. My two youngest are still in school, one in the elementary school building and one

in the secondary school building. So, I can find out through them about some opportunities to work together. And I will keep in communication with Robin on this.

- I have already had conversations with Lisa Wilcox and she has been hired by Islands Trust to work as a liasion for the indigenous history of Ganges. I will set up to speak to her again.
- I will continue to educate myself about the indigenous history of Ganges.
- I will look over the information that I have gathered on Ganges watersheds and see if there is anything I can contribute.
- I will continue to attend the monthly LTC meetings to see what the local trust is up to with their work in order to keep in touchwith their direction for Ganges.

I believe that we agreed that the more we learn about what other groups have already done, and also about the working projects currently ongoing through the Islands Trust, and communicate with the other groups too, then we will get things done and it won't be too much for each one of us. There are concurrent projects already going on, and they do address the needs of Ganges, so I am sure we can work to pull that together and it will work well.

I must say that I still had the information from the LTC (local trust committee) meeting I attended via zoom on August 31 going through my mind.

The task forces were one of the topics and Jennifer Fix was introduced. She is a consultant who will be working on public engagement for the Ganges vision, and she will be facilitating public engagement and milestones. I am certain we will manage this project in an easy and enjoyable manner.

This is my summary from today, I definitely learned a lot more from each of you than what I have written and it has brought us closer by meeting today.

# **Ganges Village Planning Public Engagement Plan**

#### What is this Engagement Plan?

On October 6, 2020, the Salt Spring Island Local Trust Committee (SSI LTC) directed staff to develop an area plan for Ganges Village to be referenced in the Official Community Plan for Ganges Village to ensure a healthy, resilient and environmentally sustainable future generations. village and parameters for this village planning initiative include the Islands Trust's commitment to preserve and protect the unique and fragile environment of the island; to address the Climate Emergency; and to advance reconciliation efforts set forth in the Reconciliation Declaration and the Reconciliation Action Plan 2019-2022. This project will build on work by community groups, government agencies and collaboration with **Nations** First and stakeholders.



This Engagement Plan intends to implement the principles identified in the approved <u>Ganges Village Planning Public Engagement Framework</u> by providing a detailed plan of engagement activities with the stakeholders, agencies and the general public. The interest of First Nations is a key element of this plan, and the <u>First Nations Engagement Principles</u> of the Islands Trust will apply in the engagement process. To ensure a meaningful consultation with First Nations, the processes will include on-going engagement with First Nations with treaty and territorial interests in the area of Salt Spring Island. The collaboration and consultation will be reflective of the Trust Council adopted policy on <u>First Nations Engagement Principles</u>, and the foundation documents of the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP), Truth and Reconciliation Commission Calls to Action, and Missing and Murdered Indigenous Women and Girls Calls for Justice. Engagement process will be guided by concerns or responses from First Nations on how to proceed in a mutually respectful, collaborative relationship-building framework. Finally, this Engagement Plan intends to allow for flexibility to respond to any unforeseen circumstances and changes in the resource capacity, to adjust any gaps in the strategies, or to improve any deficiency in the process midstream. The Plan will also be revised should funding become available for a consulting service to take over the public engagement process.

#### 1. Public Engagement Process Objectives

The intent of the engagement process is to provide a meaningful public engagement process and to achieve the following goals:

- a. To promote awareness amongst islanders and the general public
- b. To *inform* the community, agencies and First Nations on relevant issues and critical information in the planning process
- c. To *collaborate* effectively with the community on brainstorming of issues and exploring solutions
- d. To offer opportunities for all to be heard and to voice their concerns
- e. To commit to a transparent process with ongoing updates and opportunities for feedback

#### 9. Public Engagement Tools

Various engagement tools will be utilized to ensure a meaningful outreach and engagement process. The tools utilized below are not exhausted, should additional resources become available to the project for additional public engagement activities, this Public Engagement Plan will likely expand and more tools could be incorporated.

#### **Project Webpage**

A project webpage will be maintained for the duration of the planning process. The webpage will provide information about the project, including the Ganges Village Planning Project Charter, Ganges Village Planning Task Force Terms of Reference, Ganges Village Planning Public Engagement Framework, and a list of relevant documents. The webpage will also provide an online survey, as well as various public engagement updates to keep the community informed. Understanding some people may not have access to the internet, the Project Webpage provides a cost-effective means to post notifications, project updates and various community outreach activities, and to reach a diverse population on the island and beyond.

#### **Brochures/Paper Mails**

An easy-to-understand and graphically-engaging document that highlights key elements of the project, updates and general information will be made available online, printed copies may also be available at various locations such as Salt Spring Island Local Planning Office, community centers, and various community-organizations. Paper mailings on legal notifications will be available to properties on public hearings and on properties that will be affected by any particularly proposed regulatory requirements.

#### Advertising

Paid advertising from local newspaper will be provided on any public meetings and may be utilized to promote upcoming project events.

#### Survey

Various surveys related to different phases of the project will be posted on the Project Webpage to seek input from the community. At different stages of the project, a set of questions will be posted online in an attempt to seek input from the respondents. Well-crafted questions can elicit a wealth of valuable insight with statistical validity. This technique is effective for understanding public opinion and preferences to help identify key issues.

#### Workshops

When permitted under B.C. Health protocols, a variety of workshops such as community events, stakeholders' workshops, classroom workshops, and design charrettes may be held throughout the duration of the project. Café-style workshop is often a great way to bring a diverse group of people

together to have simultaneous conversation, to share community's concerns and to explore alternative solutions. Each round of discussion per table or small group focuses on one key question, before each person moves to a new different group for the next round. This type of setting has been proven to be very successful in allowing diverse perspectives to be heard and collaborating on collective solutions. Design charrettes have also been a popular part of a public engagement process as they bring together a diverse range of expertise (architects, landscape architects, engineers, planners, content specialists, educators, students, community representatives, and governmental staff) to collaborate on innovative design solutions that are based on mutual interests. Design charrette helps translating ideas into visual form which and is an effective form of engagement in generating creative solutions to difficult problems in the least amount of time. Classroom workshop is another option to partnering with local schools, which offer a fun and interactive means to engage with students, and a great way to stimulate ideas from the future generation while fostering youth in civic engagement.

#### **Open House**

Open house is an informal setting with the project team present to highlight specific topics. The public is free to peruse the various areas and interact with the project team. This is a good technique for seeking input on specific options or alternatives, but it is fairly resource-intensive and capturing all public comment in this format may be challenging.

#### Virtual Coffee with Planner

In an attempt to provide additional opportunities for the public to discuss the project with the project planner, a web-based (Zoom) or telephonic ½ hour conversation will be available every Thursday morning from 9:30 a.m. to 11:30 a.m. A request to have the conversation can be emailed to the project planner via the Project webpage or at lgarbo@islandstrust.bc.ca by noon of the Wednesday before. Due to the limited time available, conversation should be within the scope of the project and not bylaw enforcement, development application or permit on a specific property.

#### **Public Hearing**

Public hearings allow affected citizens to provide their views to their elected representatives on any proposed bylaw. It is a formal meeting with a presentation and dedicated time for public comment. At the public hearing, all persons who believe that their interest in property is affected by the proposed bylaw must be afforded a reasonable opportunity to be heard. This involves an opportunity to make a speech or presentation to the elected officials or to present a written submission. In many cases, notices about the public hearing may also indicate a time and location to submit comments prior to the public hearing.
