As a Salt Spring resident, I'm aware of how divisive the housing conversation on Salt Spring has been, particularly because of a perception that we have to choose between the affordable housing our community needs and the natural environment we all love and want to protect. But all the Salt Springers with whom I've discussed this topic agree that our community is strongest when we agree on certain principles:

**WE SUPPORT WORKFORCE HOUSING**

We want to prioritize affordable housing for local workers, farm-workers, low-income, and young residents to keep our community thriving.

**WE WANT TO PLAN FOR CLIMATE RESILIENCE**

We want to change our patterns of community so that current and future affordable housing development is protected from, and does not worsen, climate impacts like floods, wildfires, and extreme weather by planning with science and future risks in mind.

**WE WANT DIVERSE CLUSTERED HOUSING**

We support co-housing, eco-villages, tiny homes, and multi-unit developments that are affordable, environmentally friendly, and surrounded by protected ecosystems.

**WE WANT WALKABLE, CONNECTED NEIGHBOURHOODS THAT SERVE ALL OF US**

We want to design our communities with homes, workspaces, shops, and services that are close together, affordable, and serve the needs of all Salt Springers, including seniors, families and the disabled and marginalized.

**WE WANT TO RESPECT INDIGENOUS LEADERSHIP**

We want our local government to work with local First Nations and Tribes in all planning, especially in sensitive cultural and ecological areas.

**WE WANT TO STRENGTHEN LOCAL FOOD SYSTEMS**

We want to ensure new development supports farmland protection and strengthens access to local food.

Because I support these principles, I'm writing in support of the report submitted to the LTC titled "Common Ground Consensus for the Future," a package of proposals generated by a diverse group of community representatives, aligned with the LTC's 3 lenses for housing input on revision of our Official Community Plan and land use bylaws, and reviewed by a planner for legality, feasibility and relevance to your process.

Given the short timeframe for the LTC's public engagement, I feel the Common Ground work should be foundational to our future OCP-LUB revisions.
