All in all, we estimate that this single issue has taken us at least 80 hours of combined professional time over the course of 4-5 years. We did this first and foremost as concerned citizens, but citizens with high level professional credentials and extensive experience in these matters, both within Government and Academia. We have been dismayed thus far by the lack of acknowledgement of and response to our efforts by our elected officials, while receiving much encouragement and appreciation from community members.

We trust that we have brought to your attention and extensively documented an issue of utmost importance – both for the future of water issues on the island and for matters of transparency and accountability of our elected officials. At this point, we respectfully ask, once again, that an in-depth, arms-length review of this situation be finally carried out, and that the results be shared with the Salt Spring community in a well-considered thoughtful report.
